Make a difference with a career in Social Work. Studying a bachelor's will help you to develop a practice model that integrates non-indigenous and indigenous theories, models, thinking and skills, which can help to enhance working with family and whānau and more in the community.

## Programme outline

This programme is designed to meet the professional and educational requirements of the Social Workers Registration Board (SWRB) and New Zealand Qualification Authority (NZQA) and in doing so provides those who choose to study at Whitireia with a sound social work education, a recognised qualification, and a pathway to higher qualifications.

## More detail about this qualification

### Teaching and learning

On campus learning days are usually 9:00am-3:00pm on Thursdays and Fridays. Online tutorials will take place on the non-campus days and are an essential part of your learning journey, and will include course content and Tūāpapa tautoko.

The online tutorials will require you to have a computer and internet access at home. Students will also need to be able to work from home should Covid-19 Alert Levels change.

### Year one

In this first year, the formation of the student's identity as a social worker is increasingly supported by their ability to access new and relevant technical information and analyse and interpret it for new and relevant contexts.

### Year two

Year two introduces the student to the nature of the social worker/client relationship, the roles of the social worker, the responsibilities that ensue from these roles, and a range of contexts where social work occurs.

### Year three

Year three learning provides the student with the opportunity to consolidate their knowledge and understanding of the social worker 'identity' and the principles and practices that keep them, their clients and the organisation within which they are placed, safe. The body of knowledge related to social work, culture and research informs the student's identity as a training social worker.

### Year four

Students are enabled to confirm the competencies expected of them as work-ready, new social work practitioners. They take responsibility for their actions, are informed by the many dimensions of social work knowledge, and critically reflect on their own actions and responses, as well as those of others.

## Fieldwork placements

Students must complete their fieldwork placement experience of 12 weeks (60 days) in both Years 3 and 4. Over this 12-week period, students can expect to complete 60 days full time, with varied hours of work.

**Please note, fieldwork placements may not be in the area that you live.**

The cost of transportation to and from fieldwork placements is the student's responsibility. If students are working part-time priority must be given to attending fieldwork placements.

## Course related costs

The following costs are approximate. Confirmed costs for next year and first day information will be available here from 01 October.

Health screening\*: \$250

\*Health Screening: In years three and four, health screening/vaccinations may be a prerequisite for attendance at some of the fieldwork placements. Students will be advised whether this is a requirement when their placement is confirmed. Please note students are responsible for any costs involved.

Applicants for whom English is an alternate language and who have not undertaken secondary education in English Māori or New Zealand Sign Language.

### **Interview/Evidence of suitability**

The interview determines the applicant's preparedness for study and ability to meet the Health Practitioner's Competence Assurance Act 2003, as well as any registration board requirements in terms of being fit for registration. Applicants must be able to demonstrate the following qualities:

- Effective interpersonal communication skills
- Appropriate presentation
- Maturity and a positive attitude
- Commitment and motivation to succeed

Once course numbers are met, students are wait-listed in order of the date on which their application was submitted.

### **Safety check**

The Children's Act (2014) requires all students, who may work with children during the course of their study, to be safety checked. Safety checking includes reference checking, work history, identity check, police vet and an overall assessment of the applicant's safety to work with children.

### **Health screening**

Students may be required to complete health screening to provide current evidence of their immunisation status, required by Te Puna Whai Ora | Ministry of Health and health organisations offering clinical learning experiences.

If students are placed at a fieldwork placement that is covered by the COVID-19 Public Health Response (Vaccinations) Order 2021, they will be required to be

fully vaccinated against COVID, including a booster dose, as they will have frequent contact/engagement with those providing health services and are considered tied to a role within a healthcare setting.

These requirements would be discussed with students attending one of these fieldwork placements.

### **I'm unsure I meet the entry requirements**

If you are unsure whether you meet the entry requirements, you should still apply. For some applicants we may recommend completion of some FREE Tūāpapa study modules prior to the start of the programme, which will build on your current skills and experiences to support your academic achievement.

### **Credit recognition**

If you have relevant skills and knowledge through study or experiences in work or other activities, you may be able to receive credit for them when enrolling in a programme of study. This is done through a process called [credit recognition](#).

Before you start your online application, you will need to have the following documentation available to upload when requested:

- Verified official transcripts
