Study to become a veterinary nurse assistant and learn and practice a range of clinical skills in both classroom and workplace settings. After completing this programme, you'll be able to apply for registration with the New Zealand Veterinary Association as a Veterinary Nursing Assistant or you can continue onto the New Zealand Diploma in Veterinary Nursing (Level 6) programme (run in conjunction with Otago Polytechnic).

## Flexible study options

This programme is delivered by blended learning i.e. face to face and online learning. This means some of your lessons may be delivered via Moodle (our online learning platform), which will require you to have a computer and internet access at home. Students will also need to be able to study from home should Covid-19 Alert Levels change.

## More detail about this qualification

### Courses

#### **VN4100: Introduction to Professional Practice**

To enable students to demonstrate knowledge and skills essential for professional practice in veterinary practices.

#### **VN4101: Animal Health and Husbandry**

To enable students to demonstrate an understanding of animal health and husbandry and apply this while working with animals in an animal care facility.

#### **VN4102: Reception and Client Services**

To enable students to provide client and patient services in an animal care facility.

#### **VN5100: Clinical Practice**

To enable students to develop clinical practice, knowledge and skills, and use these while assisting the veterinary nurse or veterinarian. Under this subject students will learn the vital importance of animal welfare and how to maintain it amongst other things. Students will also learn about diseases both common and preventable and how to manage them.

#### **VN5101: Diagnostics and Hospitalised Patient Care**

To enable students how to demonstrate knowledge of diagnostic and hospitalised patient procedures and practices by assisting with these in a veterinary clinic. Students will also learn how to manage and care for the hospitalized patient and laboratory work.

#### **VN5102: Surgery Preparation and Anaesthesia**

To enable students to develop and apply skills and techniques essential for assisting in surgery and with anaesthesia.

#### **VN5103: Professional Practice**

To enable students to demonstrate integration of knowledge, skills and behaviours through providing professional veterinary nursing assistance in a veterinary clinic.

### Teaching and learning

To succeed in this programme, you will need to attend all scheduled on-campus classes, complete all your work placement hours, and complete your self-directed learning (most of which is online in Moodle). The programme is largely classroom based, with theory to support practical application. You will be involved in practical lessons as well as regular self-directed learning, including group work, where you will undertake a variety of tasks such as research projects and case studies.

### Work placement

Students must attend and complete a minimum of 240 work placement hours during the programme. You will need to secure your own placement in a veterinary clinic to complete a minimum of 240 hours. More detailed information regarding placement requirements will be provided at interview. You will need to arrange your own travel to and from your work

### **Important Note:**

Please note that even though the work is enjoyable, some students may find some situations emotionally distressing, such as animals that have been abused, are injured or sick, or require euthanasia.

### **Allergies**

If you have any allergies to animals, it is important to declare this at the time of enrolment, so this can be discussed with you.

### **Career options**

Graduates of this qualification may be employed as a Veterinary Nurse Assistant working with companion animals in an animal-related facility and be able to:

- Maintain animal health and husbandry of animals in a veterinary clinic
- Care for hospitalised patients.
- Assist in surgery preparation and anaesthesia
- Assist with routine diagnostic procedures.

### **Entry requirements**

#### **Domestic**

60 credits at NCEA Level 2 with at least 12 credits in Level 2 English, 12 credits in Level 1 Maths and 12 credits of relevant science at Level 1, or equivalent tertiary study, or meets the education provider's requirements for the equivalent numeracy and literacy standards.

#### **International**

A minimum IELTS (Academic) score of 6.0 with no band score lower than 5.5, or equivalent.

OR

Achieved the academic entry requirements in New Zealand or at an institution where English was the language of instruction and assessment.

#### **Additional requirements**

### **Applicants must:**

- be a minimum of 18 years of age at the commencement of the programme
- provide a curriculum vitae and two reference
- provide a medical declaration indicating there is no evidence of a medical condition that will impact on their ability to practice safely as a veterinary nurse assistant
- have at least three days of work experience and/or observation of animals within a veterinary clinic
- undergo a police check at the time of entry into the programme. In the event of an adverse police report, entry into the programme will be at the discretion of the Head of School. In exceptional circumstances, the requirement for a police check may be waived by the Head of School
- students need to come in with a work placement.

### **Applicants must attend an interview which is used to discuss:**

- preparedness and commitment to study
- identification of strengths and weaknesses related to study
- good character and aptitude for working with animals and the public.

The outcome of the interview will help determine the success of the enrolment.

Where it is suggested that the applicant is not ready to undertake the programme they will be supported to explore alternative study pathways.
